가입대상

- 대한민국에서 6개월 이상 체류한 외국인 및 재외국민
 - 유학 또는 결혼이민은 입국 즉시 가입



가입절차

- 별도의 신고 절차 없이 공단에서 가입처리
 - 가입 안내문, 보험료 고지서 등 미수령 시 방문신고



보험료 및 보험급여

- (보험료) 소득·재산 등에 따라 세대별로 보험료 산정 (2019년도 기준 113,050원 이상)
- 세대단위로 보험료 납부를 원하는 경우에 공단 관할 지사 방문하여 세대합가 신청 필요
- ☞ 세대합가 기준(동일한 체류지에 거주하는 배우자 및 19세미만 자녀)
- (보험급여) 대한민국 국민과 동등하게 보험급여 혜택을 받음



보험료 체납시 불이익

- · 병·의원 이용시 건강보험 혜택 제한
- 법무부 출입국·외국인관서에 비자연장 등 신청시 체류허가 제한

Foreigners and overseas Korean who have stayed more than 6 months in Korea should be enrolled in the National Health Insurance mandatorily

The National Health Insurance is here to safeguard your healthy life.



Eligibility

- Foreigners and overseas Korean who have resided in the Republic of Korea for more than six months
 - Foreigners who are visa holders of study(D-2) or marriage(F-6) are entitled to enroll as a date of entry into Korea.



Procedure to enrollment

- One can subscribe at the National Health Insurance Service without any reporting procedure
 - If you do not receive any information sheet on how to register to the NHIS or an insurance contribution bill to pay, please visit a nearby NHIS Branch Office.



Insurance contribution and benefits

- (Insurance contribution) Each household's insurance contribution is calculated based on income and property of its household members (The average of each household's contribution is over KRW 113,050 as of 2019)
 - If you wish to pay the insurance contribution as a family unit, visit a branch office of the service and ask to add your family members under your name (or the name of householder)
 - Criteria for combining into one household are as follows
 - The residential addresses of family members are to be same
 - 2 The scope of family members is a spouse and minor childern (aged under 19)
- -- · (Insurance benefits) Same benefits as the citizens of the Republic of Korea have



Restrictions on health insurance benefits in case of delaying payment of the insurance contribution

- Your health insurance benefits would be restricted when visiting hospitals and clinics
- Your residence permit would not be granted when requesting for a visa extension at the Korea Immigration Service of the Korean Ministry of Justice.
